Summary of Findings

Curriculum C-

- IUSM dedicates a lot of time to social determinants of health in its core curriculum. Students gain an understanding that environmental exposures have a disproportionate impact on marginalized communities.
- Planetary Health connections in the curriculum should be made more explicit, with more dedicated time. The medical school should identify Planetary Health (including climate change) as a priority theme and include that material in learning objectives and test questions. The medical school should offer an elective on Planetary Health for students to gain a more in-depth understanding of the impact of climate change on human health.

Interdisciplinary Research

D

- IUSM lacks an institute for interdisciplinary Planetary Health research that emphasizes the impacts of anthropogenic environmental changes on health. IUSM may draw from existing centers and groups such as Richard M. Fairbanks School of Public Health, IU School of Public Health, Paul H. O'Neill School of Public and Environmental Affairs, Center for Urban Health, Sustainable Development Goals Working Group, Environmental Resilience Institute, and its partnership with Moi University.
- The medical school should commit to involvement in the recruitment of and engagement with Planetary Health researchers.

Community Outreach and Advocacy

F

- The institution has a centralized Office of Sustainability website that links the sustainability efforts at every IU campus. There is an opportunity to add a section for future Planetary Health initiatives on the website.
- IUSM should partner with local communities affected by climate change and pollution to share information about environmental health threats, advocate together for change, and provide opportunities for students to be a part of this work.

Support for Student-Led Initiatives

- IUSM administration is supportive of Planetary Health initiatives introduced and led by students...
- The administration could further support student-led initiatives by facilitating connections between research mentors and students, creating grant opportunities, and developing a student fellowship program designated for Planetary Health.
- It would be beneficial for IUSM to have a student liaison representing sustainability interests who serves on a decision-making council.

Sustainability

C

- IU has implemented robust strategies to encourage and provide environmentally-friendly transportation options for students and reduce the environmental impact of commuting.
- IUSM has many opportunities to improve its sustainability practices: divest from fossil fuels, implement composting, use renewable energy for campus buildings, and implement programs to make labs more environmentally sustainable.

Statement of Purpose

Planetary health is human health.

The Planetary Health Alliance defines planetary health as "a field focused on characterizing the human health impacts of human-caused disruptions of Earth's natural systems." This definition is intentionally broad, intended to encompass the multitude of ways that the environment can affect health, including water scarcity, changing food systems, urbanization, biodiversity shifts, natural disasters, climate change, changing land use and land cover, global pollution, and changing biogeochemical flows. The health of humanity is dependent on our environment and our environment is changing rapidly and in disastrous ways. Although the World Health Organization has called climate change "the greatest threat to global health in the 21st century," many medical school's institutional priorities do not reflect the urgency of this danger to human health.

As future health professionals, we must be prepared to address the impacts of human-caused environmental changes on our patients' health. This preparation is in the hands of the institutions providing our medical training. It is imperative that we hold our institutions accountable for educating medical students about the health impacts of climate change and other anthropogenic environmental changes, generating research to better understand health impacts and solutions, supporting related student initiatives, embracing sustainable practices as much as possible, and engaging with surrounding communities that are most affected by environmental threats. Because climate change and environmental threats disproportionately affect vulnerable populations (for example, communities of color, older adults sensitive to health threats, and individuals in low-resource settings), these issues are inherently ones of equity and justice.

With the purpose of increasing planetary health awareness and accountability among medical schools, we have created a Planetary Health Report Card that medical students internationally can use to grade and compare their home institutions on an annual basis. This medical-student-driven initiative aims to compare medical schools on the basis of discrete metrics in five main category areas: 1) planetary health curriculum, 2) interdisciplinary research in health and environment, 3) university support for student planetary health initiatives, and 4) community outreach centered on environmental health impacts 5) medical school campus sustainability.

Definitions & Other Considerations

Medical school-specific considerations:

- Indiana University School of Medicine ("IUSM") has nine campuses throughout Indiana. Its largest campus is located in Indianapolis, IN.
- For metrics that specify "medical school," scores were given by reviewing school-wide policies that affect all nine campuses, unless stated otherwise.
- Metrics that specify "institution" refer to Indiana University ("IU"). IU has two core campuses in Bloomington, IN ("IU Bloomington") and Indianapolis, IN ("IUPUI"). There are seven extension campuses throughout Indiana.

Planetary Health Curriculum

<u>Section Overview:</u> This section evaluates the integration of relevant planetary health topics into the medical school curriculum. Today's medical students will be on the frontlines of tackling the health effects of climate change. Therefore, it is critical that medical students are trained to understand the health effects of climate change, as well as planetary health more broadly. Topics like the changing geography of vector-borne diseases, the health consequences of air pollution, environmental health inequities, and disaster response principles must be part of every medical school's core curriculum.

Score explanation: In the M1 course Fundamentals of Health and Disease, there was a 2021 lecture by Dr. Dan Lodge-Rigal titled "Environmental Injury." This lecture included a very brief discussion on increasing infectious disease due to climate change.

In the past, students used to conduct a neighborhood drive-through to better understand the community local to the medical school. This year it was conducted virtually during the interdisciplinary group meeting/project.

These address the unequal distribution of exposure to anthropogenic environmental pollutants, such that low SES, women, communities of color, children, homeless populations, and older adults are more likely to experience higher exposure rates and adverse effects.

 Score explanation: This topic was not covered in IUSM core curriculum or elective coursework.
- 17. In training for patient encounters, does your medical school's curriculum introduce strategies for taking an environmental history or exposure history?
 Yes, the core curriculum includes strategies for taking an environmental history.
 Only elective coursework includes strategies for taking an environmental history.
 No, the curriculum does not include strategies for taking an environmental history.

Score explanation: Students are trained to take a full history, which includes asking about environmental exposure (e.g. through travel, home environment, etc) and occupational exposure, during their Foundations of Clinical Practice 1 course.

Curriculum: Administrative Support for Planetary Health

18. Is your medical school currently in the process of improving Education for Sustainable Healthcare (ESH)/planetary health education? Yes, the medical school is currently in the process of making major improvements to ESH/planetary health education. Yes, the medical school is currently in the process of making minor improvements to ESH/planetary health education. No, there are no improvements to planetary health education in progress.

Score explanation: The school is in the process of making minor improvements. The environmental impact on health has been included as a learning objective for modules, discussions, and lectures, which indicates that it is being considered and prioritized in curriculum development. However, planetary health and environmental health are rarely explicitly addressed within these lectures or small group questions.

19. How well are the aforementioned planetary health/Education for Sustainable Healthcare topics integrated longitudinally into the core curriculum? 6 Planetary health/ESH topics are well integrated into the core medical school curriculum. 4 Some planetary health/ESH topics are appropriately integrated into the core medical student curriculum. 7 Planetary health/ESH is not integrated and is primarily addressed in (a) standalone lecture(s). 8 There is minimal/no education for sustainable healthcare.

Score explanation: Environmental health/climate change are addressed predominantly in two lectures within the curriculum: the Foundations of Clinical Practice 1 lecture "Poverty, Neighborhood, and Environment," and the Fundamentals of Host and Disease lecture "Environmental Injury." There are no cases/small groups integrating planetary health effects across various organ systems/in multiple courses.

20. Bonus: Does your medical school have a program that offers incentives for

faculty/departments to develop new planetary health/ESH courses and/or incorporate planetary health/ESH into existing courses?

1* Yes, the medical school has an incentive program.

No, the medical school does not have an incentive program.

Score explanation: IUSM does not have an incentive program for faculty/departments to develop new planetary health/ESH courses and/or incorporate planetary health/ESH into existing courses.

Interdisciplinary Research

<u>Section Overview:</u> This section evaluates the quality and quantity of interdisciplinary planetary health research at the medical school and broader institution. Interactions between health and the environment are complex and multifactorial. While climate change has been extensively studied from an environmental science perspective, planetary health is an emerging field. As leading health institutions with talented researchers and research resources, medical schools should fund research studying the health effects of climate change and anthropogenic environmental toxins. This obligation is particularly strong because the public and policymakers are more attentive to climate change when its implications for human health are emphasized.

1. Are there researchers engaged in planetary health research and healthcare sustainability research at your medical school? 4 Yes, there are faculty members at the School of Medicine who have a primary research focus in planetary health and healthcare sustainability. 3 Yes, there are faculty members at the School of Medicine who have a primary research focus in a planetary health or healthcare sustainability. 2 Yes, there are individual faculty members at the School of Medicine who are conducting research related to planetary health or healthcare sustainability, but it is not their primary research focus. 1 There are planetary health and/or healthcare sustainability researchers at the institution, but none associated with the medical school. O No, there are no planetary health and/or healthcare sustainability researchers at the institution or medical school at this time.

Score explanation: There are planetary health researchers at the institution. The Center for Urban Health "stimulate[s] collaborative efforts to explore connections between environment, behavior, health, and climate as related to urban environments." Dr. Gabriel Filippelli is a biogeochemist at IUPUI. His research "focuses on the flow and cycling of elements and chemicals in the environment. This includes his work on pollutant distribution and exposure to human populations, and ways to engage communities to reduce their own exposures."

2. Is there a dedicated department or institute for interdisciplinary planetary health research at your institution? There is at least one dedicated department or institute for interdisciplinary planetary health research. There is not currently a department or institute for interdisciplinary planetary health research, but there are plans to open one in the next 3 years. There is an Occupational and Environmental Health department, but no interdisciplinary department or institute for planetary health research.

There is no dedicated department or institute.

Score explanation: IUPUI has the Richard M. Fairbanks School of Public Health Global Health Research Department which is affiliated with the Consortium of Universities for Global Health (CUGH), in addition to the Center for Earth and Environmental Science (CEES). The CEES mission is to "provide interdisciplinary research solutions to environmental challenges facing Central Indiana". The CUGH partners with academic institutions across the world to "improve the wellbeing of people and the planet through education, research, service, and advocacy".

3. Is there a process by which communities disproportionately impacted by climate change and environmental injustice give input or make decisions about the research agenda at your medical school?

- Yes, there is a process in which community members impacted by climate and environmental injustice have decision-making power in the climate + environmental research agenda.
- Yes, there is a process in which community members impacted by climate and environmental injustice advise the climate + environmental research agenda.
- No, but there are current efforts to establish a process for community members to advise or make decisions on the research agenda.
- 0 There is no process, and no efforts to create such a process.

Score explanation: There is no process, and no efforts to create such a process.

4. Does your institution have a planetary health website, or a website centralizing various campus resources related to health and the environment?

- There is an easy-to-use, adequately comprehensive website that centralizes various campus resources related to health and the environment including all of the following: upcoming events, leaders in planetary health at your institution, and relevant funding opportunities.
- There is a website that attempts to centralize various campus resources related to health and the environment, but it is hard-to-use, not updated, or not adequately comprehensive.
- The institution has an Office of Sustainability website that includes some resources related to health and the environment.
- 0 There is no website.

Score explanation: The institution has a centralized Office of Sustainability website that links the sustainability efforts at every IU campus. It provides resources for relevant funding or internship opportunities, directs users to on-going research and press releases, and maintains a calendar of events. There are some resources related to health and environment, but this is not the primary focus of the website.

5. Has your institution recently hosted a conference or symposium on topics related to planetary health? 4 Yes, the institution has hosted more than one conference or symposium on topics related to planetary health in the past year, including at least one on climate change. 3 Yes, the institution has hosted one conference or symposium on topics related to planetary health in the past year. 2 Yes, the institution has hosted a conference on topics related to planetary health in the past three years. 1 The institution has not hosted any conferences directly, but they have provided financial support for a local planetary health event. No, the institution has not hosted a conference on topics related to planetary health in the

Score explanation: The institution has not hosted a conference on topics related to planetary health in the past three years.

past three years.

6. Has your institution or medical school joined the Planetary Health Alliance and/or the Global Consortium on Climate and Health Education? Yes, the medical school has joined the Planetary Health Alliance and/or the Global Consortium on Climate and Health Education. Yes, the institution has joined the Planetary Health Alliance and/or the Global Consortium on Climate and Health Education, but the medical school specifically has not. No, the institution has not joined the Planetary Health Alliance or the Global Consortium on Climate and Health Education.

Score explanation: Indiana University-Bloomington and the Richard M. Fairbanks School of Public Health have both joined the Global Consortium on Climate and Health Education, but the medical school, specifically, has not. No IU institution is a member of the Planetary Health Alliance at this time.

Community Outreach and Advocacy

Section Overview: This section evaluates medical school engagement in community outreach and advocacy efforts associated with planetary health. Researching and teaching planetary health is necessary but not sufficient. It is critical that institutions also directly engage with communities most affected by environmental health harms. Although climate change is a problem largely created by those with power and resources, its impacts fall disproportionately on under-resourced populations and communities of color. Institutions should partner with local communities affected by climate change and pollution to share information about environmental health threats, advocate together for change, and provide opportunities for students to be a part of this work.

1. Does your medical school partner with community organizations to promote planetary and environmental health? Yes, the medical school meaningfully partners with multiple community organizations to promote planetary and environmental health. Yes, the medical school meaningfully partners with one community organization to promote planetary and environmental health. The institution partners with community organizations, but the medical school is not part of that partnership. No, there is no such meaningful community partnership.

Score explanation: IUPUI partners with community organizations to promote environmental health. For example, IUPUI annually hosts the <u>Indianapolis Sustainability and Resilience Conference</u> for sustainability professionals from Indiana. The conference is "designed to showcase local successes, share best practices, engage in place-based problem solving, and facilitate collaboration to advance sustainability in the Hoosier state."

2. Does your medical school offer community-facing courses or events regarding planetary health? The medical school offers community-facing courses or events at least once every year. The medical school offers courses or events open to the community at least once per year, but they are not primarily created for a community audience. The institution has offered community-facing courses or events, but the medical school was not involved in planning those courses or events. The medical school has not offered such community-facing courses or events.

Score explanation: IUSM does not offer community-facing courses or events regarding planetary health. The Environmental Resilience Institute at IU Bloomington does feature environmental resources for Indiana residents. For example, there is a *Prepared for Environmental Change* webinar series. One of the episodes focuses on the impact of climate change on food systems.

3. Does your medical school have regular coverage of issues related to planetary health and/or sustainable healthcare in university update communications?

- Yes, all students regularly receive communication updates dedicated to planetary health and/or sustainable healthcare.
- Yes, planetary health and/or sustainable healthcare topics are sometimes included in communication updates.
- Students do not regularly receive communications about planetary health or sustainable healthcare.

Score explanation: Medical students receive weekly communications from IUSM via the INScope newsletter. At times, various sustainable healthcare topics have been part of the newsletter, including LEED building updates and news of the first dining/residence hall to start composting at IUPUI.

4. Does the medical school offer continuing medical education (CME) courses that address planetary health and/or sustainable healthcare?

- Yes, multiple in-person or online CME courses relating to planetary health and/or sustainable healthcare are offered, including at least one with a primary focus of planetary health.
- Yes, one in-person or online CME course related to planetary health and/or sustainable healthcare is offered.
- 0 There are no CME courses on planetary health or sustainable healthcare topics.

Score explanation: IUSM does not offer CME courses that address planetary health and/or sustainable healthcare.

5. Do hospitals affiliated with your medical school have accessible educational materials for patients about environmental health exposures?

- 2 Yes, all affiliated hospitals have accessible educational materials for patients.
- 1 Some affiliated hospitals have accessible educational materials for patients.
- 0 No affiliated medical centers have accessible educational materials for patients.

Score explanation: Hospitals affiliated with IUSM do not have accessible educational materials for patients about environmental health exposures.

6. Do hospitals affiliated with your medical school have accessible educational materials for patients about climate change and health impacts?

- 2 Yes, all affiliated hospitals have accessible educational materials for patients.
- 1 Some affiliated hospitals have accessible educational materials for patients.
- 0 No affiliated hospitals have accessible educational materials for patients.

Score explanation: Hospitals affiliated with IUSM do not have accessible educational materials for patients about climate change and health impacts.

Support for Student-Led Planetary Health Initiatives

<u>Section Overview:</u> This section evaluates institutional support for student-led planetary health initiatives, such as funding, fellowships, programming, and student groups. Planetary health is a young field and, as young people facing a future deeply shaped by climate change, students are often some of the first at an institution to engage with it. Institutions should provide support for students to engage in sustainability quality improvement (QI) initiatives, discover mentors in their area of interest, and receive funding for planetary health projects.

1. Does your institution offer support for medical students interested in enacting a sustainability initiative? Yes, the institution offers grants available to medical students for students to enact sustainability initiatives. The medical school encourages sustainability QI projects (to fulfill clerkship or longitudinal requirements) and offers resources to help students succeed in these projects, but there is no student funding available. No, the institution does not offer opportunities or support for sustainability initiatives.

Score explanation: The institution does not offer grants for medical students on all nine campuses to enact sustainability initiatives. IUPUI awards \$50,000 annually via the Greening IUPUI Grant to student projects that improve campus sustainability. Only medical students located in Indianapolis are considered IUPUI students.

2. Does your institution offer opportunities for medical students to do research related to planetary health and/or sustainable healthcare? The institution offers an explicit paid fellowship for medical students to do research related to planetary health and/or sustainable healthcare. The institution offers paid research opportunities for students and planetary health/sustainable healthcare projects would be considered eligible. There are unfunded research opportunities for students to perform research related to planetary health/sustainable healthcare. There are no opportunities for students to receive funding for planetary health/sustainable healthcare research.

Score explanation: Students have opportunities to conduct planetary health / sustainable healthcare by partnering with various members of the IU institution (e.g. School of Public Health). IUSM offers a funded summer research program for medical students, but no Planetary Health projects were included.

IUPUI hosts an Indiana Sustainability and Resilience Conference, which is an annual gathering for sustainability events. This event is also advertised for students to attend.

In the past year, the institution has put on an exhibit titled, *Climates of Inequality: Stories of Environmental Justice* put on by the Museum Studies Program at IUPUI. This featured art, virtual tours, interactive activities, writing workshops, and theatre performances to encourage students, faculty, and the public to consider the impacts of environmental harm in Indianapolis on marginalized communities.

Center for Rural Engagement has a <u>Community Resilience Program</u> to create stronger communities in face of a changing environment.

IU Outdoor Adventures (IU Bloomington) follows Leave No Trace principles. IU Bloomington offers training for students to be certified in Leave No Trace.

IUSM offers students the opportunity to propose small-group cases to implement in core coursework. There is potential for IUSM students to propose cases that allow students to learn about planetary and/or sustainable healthcare.



Yes, the medical school has implemented strategies to encourage and provide environmentally-friendly transportation options such as safe active transport, public transport, or carpooling and these options are well-utilized by students. Alternatively, the campus location is not amenable to unsustainable forms of transportation by default.

- The medical school has implemented some strategies to provide environmentally-friendly transportation options, but the options are unsatisfactorily accessible or advertised.

Score explanation: Students are provided access to a shuttle system for <u>transportation around campus</u>, and either discounted or free bus passes for the surrounding city in Indianapolis and Bloomington are available to students. There are bike racks and bike paths on several IUSM campuses to encourage alternative modes of transportation.

6. Does your medical school have an organics recycling program (compost) and a conventional recycling program (aluminum/paper/plastic/glass)?

- Yes, the medical school has both compost and recycling programs accessible to students and faculty.
- The medical school has either recycling or compost programs accessible to students and faculty, but not both.

Score explanation: There are conventional recycling bins present on campus. For example, there are plastic recycling bins in the Ruth Lilly Medical Library (IUSM Indianapolis Campus).

7. Does the medical school apply sustainability criteria when making decisions about the campus food and beverage selections?

- Yes, the medical school has adequate sustainability requirements for food and beverages and is engaged in efforts to increase food and beverage sustainability.

Score explanation: In 2013, the first IU Food Summit was held, during which it was decided to use the Real Food Challenge framework to assess and develop sustainable food purchasing practices at the Institution. The institution has a goal to purchase 25% of its food locally and Fair Trade or certified ecologically sound by 2025. The medical school itself does not offer any dining options, and no data could be found regarding sustainable food purchasing for events hosted by the medical school.

8. Does the medical school or associated institution apply sustainability criteria when making decisions about supply procurement?

- Yes, the medical school has adequate sustainability requirements for supply procurement and is engaged in efforts to increase sustainability of procurement.

- The medical school strongly recommends or incentivizes sustainability measures, but they are not required.

Score explanation: <u>Guidelines</u> for hosting green events have been published to address sustainable practices in food/beverage, advertising, decorating, etc. The institution encourages student interest groups to certify their event as a "Green Event" with the University by filling out a short application. However, there is no incentive or requirement to do so.

10. Does your medical school have programs and initiatives to assist with making lab spaces more environmentally sustainable?

- Yes, the medical school has programs and initiatives to assist with making lab spaces more environmentally sustainable.
- There are guidelines on how to make lab spaces more environmentally sustainable, but not programs or initiatives.
- 0 There are no efforts at the medical school to make lab spaces more sustainable.

Score explanation: IUSM does not have programs and initiatives to assist with making lab spaces more environmentally sustainable.

Grading

Section Overview

This section focuses on the grading of the report card. The institution received a grade for each of the individual sections as well as an overall institutional grade. Section point totals were tallied, divided by the total points available for the section, and converted to a percentage.
